- (2) A \$5.00 per ton Transfer Fee will be applied to each ton of Refuse delivered to the TS.
- (3) A \$9.00 per ton Transfer Fee will be applied to each ton of Construction/Demolition Waste delivered to the TS.
- (4) Minimum Fee \$35.00
- (5) Minimum Fee \$15.00
- (6) Minimum Fee \$25.00
